**Minutes of 387th Central Council One Point Agenda
Meeting of IEEEEP**

The 387th Central Council meeting was held on Saturday, 16th September 2017 at 11:00 a.m. at IEEEEP HQ Office, 4 Lawrence Road, Lahore.

The meeting started with the recitation from the Holy Quran.

List of participants and regrets is attached as Annex-A.

1. Objection Filed By Central Council Member Before the President IEEEEP and Chief Election Commissioner Regarding Non-Eligibility of Nomination of Engr. Dr. Prof. Suhail Aftab Qureshi as a proposed candidate for the office of Hony. Secretary General IEEEEP in the forthcoming Elections of proposed Central Council/Office Bearers 2017-19.

Hony. Secretary General informed the house that copies of letter # IEEEEP-357/HQ/17/2428 dt 13.9.2017 issued in continuation of Secretary Election Commission 2017 # IEEEEP-357/HQ/17/2427 dt. 12.9.2017 along with the minutes of 1st Meeting of the Election Commission issued vide # IEEEEP-357/HQ/17/2374 dt 9.9.2017 have been provided to all the participants (copies attached). He requested Engr. Fazal Rahmaan Chief Election Commissioner to elaborate the findings of Election Commission before the house to make final decision being the highest forum of IEEEEP expressing the collective wisdom of the Institution.

Engr. Fazal Rahmaan elaborated all pros and cons of the issue in line with the contentions narrated in the above referred minutes issued by Election Commission. The Chief Election Commissioner concluded that the Constitution must always prevail and in instant case Constitution Article-10 (iii) when read with Article-5 of the Constitution, along with Clause-6 of the Bye-laws "Terms of Office of the Office Bearers" as amended in "EOGM held on 14.11.1996", provides that Engr. Prof. Dr. Suhail Aftab Qureshi having acted as HSG in the last CC 2011-2014 cannot be nominated for the same post until a period between five consecutive AGMs has not passed. Therefore, some other suitable replacement be nominated to enable the Election Commission to proceed

ahead in accordance with relevant provision of Constitution, Bye-laws and Rules of the Institution.

Engr. Mohsin M. Syed President IEEEEP asked the house for offering their point of views on the issue one-by-one addressing him and requested that while any learned member is explaining his views before the house no one should interrupt him, every member willing to express will be given due time on his turn.

Engr. Tahir Basharat Cheema was asked by the President to explain his views. Learned CC member explained the house that issue pertains to the elaboration of Constitution and Bye-laws in respect of eligibility of Engr. Prof. Dr. Suhail Aftab Qureshi. He personally opted to consult a Barrister at law for guidance and found that we should keep in mind that whenever people feels any anomaly among the secondary law in contradiction to the primary law then primary law shall prevail.

He suggested that he is of the view that there are anomalies in the secondary laws of the Institution which should be got rectified by conducting a fresh EOGM. He also pointed out another way-out for the consideration of the house that the issue may be got resolved through the arbitration section-39 of the Bye-laws observing the provision of the Pakistan Arbitration Act 1940.

After Engr. Tahir Basharat Cheema, Engr. Shahid Aslam explained his views before the house. He said that there are no two parties in the case hence no question of arbitration stands. Naturally, learned CC members may have difference of opinions but the collective wisdom of the Institution is fully capable to elaborate the laws. He refused to accept that there is any anomaly in the primary or secondary law and explained that rules are very clear hence Engr. Prof. Dr. Suhail Aftab Qureshi having acted as HSG in the last CC 2011-2014 cannot be nominated for the same post until a period between five consecutive AGMs has not passed. Therefore, some other suitable replacement be nominated.

Then Engr. Ijaz Rabbani referring Article-3 (iv) of the Constitution, Article-10 (iii) when read in conjunction with Section-6 of the Bye-laws informed the house that only Hony. Treasurer could become eligible to be consecutively nominated to hold any of the offices among HSG/HJS/HT, for forthcoming term while elaborating that no anomaly exists among the primary and secondary law of the institution. He ended his discussion fully backing the views of Engr. Shahid Aslam.

Engr. Suleman Najib Khan added that world history substantiate that constitutions are made and amended from time to time, as it is never a divine book. If house deems suitable changes could be made in the AGM. He was of the view that conduction of fresh AGM is the solution to the problem being considered by the house.

Engr. Muhammad Daud pointed out that amendments if made could be applicable to resolve the problems faced by the CC in forthcoming periods. This problem will have to be resolved in the light of elaborations of laws made by this forum in the capacity of representing the collective wisdom of the Institution. The difference of opinion among some members is restricted only to the application of bye-laws and not the constitution. He backed the views of Engr. Shahid Aslam.

Engr. Asghar Ali Randhawa said that the Institution should not be politicized to accommodate a specific person and Constitution must prevail. He agreed with the elaborations made by Engr. Shahid Aslam.

Engr. Mohsin M. Syed pointed out that the problem being considered by the house is not about the amendments in the Constitution or other relevant laws rather about the conclusions drawn by the Chief Election Commissioner Engr. Fazal Rahmaan are acceptable to the house in view of its collective wisdom.

Engr. Mian Sultan Mahmood suggested that voting of the members should not be sought as this trend speaks that the due value has not accredited to the decision of authorized person i.e. Chief Election Commissioner.

Engr. Mohsin M. Syed explained that the conclusion drawn by the sub-committees are never binding on the house that is why the Chief Election Commissioner has opted to bring the matter with his recommendations for its finalization by the house. All other sitting members conveyed their implied consent to the recommendations made by Chief Election Commissioner. The President IEEEEP declared that house collectively approve the recommendations of Chief Election Commissioner that Engr. Prof. Dr. Suhail Aftab Qureshi having acted as HSG in the last IEEEEP Council 2011-2014 cannot be nominated for the same post until a period between five consecutive AGMs has not passed. Therefore, some other suitable replacement be nominated.

2. Any Other Point with the permission of the Chair

Engr. Mohsin M. Syed invited the attention of the house

to deliberate the recommendations of A & F committee regarding provision of funds to Lahore Local Centre to meet the financial short fall in organizing a forthcoming seminar.

Engr. Dr. Khawaja Riffat Hassan Secretary LLC informed the house that LLC has arranged different seminars in the recent past on the topics of green energy development by use of PV Solar technologies and wind mill technologies. Energy-Audit, Engineers a Complete Solution to the energy crisis etc. and promoted the cause of IEEEEP i.e. dissemination of technical knowledge. In recent past LLC remained fully successful in organizing events attracting huge gathering consisting of young engineers, Eminent Professionals, renowned Entrepreneurs and notables from the society, with a credible media coverage awarding CPD points to the participants in some of those events. Presently, he has contacted many companies for extending sponsorship and urged IEEEEP HQ to extend an amount of Rupees Five Lacs to LLC to meet the shortfall of finance to conduct the forthcoming seminar. He added that LLC will remain oblige to return funds extended by IEEEEP HQ to the extent it succeed in arranging through sponsors.

Engr. Tahir Basharat Cheema appreciated the efforts of LLC and supported the demand made by the LLC with the condition that LLC should continue to make their best possible efforts to raise funds from the sponsors so that money extended by HQ be returned back. HQ highly appreciates the spirits of LLC to make his best efforts to hold the function from their self generated sources and willingness to pay back the money extended by the HQ. IEEEEP will be pleased even if some part of the amount remained unpaid because of shortfall in the sponsorships. And will be obliged to exempt return of balance unpaid amount after seeking formal approval from the forthcoming central council meeting. It will not be out of place to mention here that formal internal Audit report for the last 3 years may also be provided to HQ for the completion of formal records.

Engr. Mian Sultan Mahmood appreciated the achievements made by LLC for the cause of IEEEEP and agreed with the suggestions of Engr. Tahir Basharat Cheema.

Engr. Suleman Najib Khan suggested that a committee be made by IEEEEP to support the WAPDA design department to enhance the efficiency and capacity of NTDC. Engr. Mohsin M. Syed strongly endorsed the suggestion.

In the end, Engr. M. Ijaz dar proposed the name of Engr.

Shahid Aslam as HSG for the upcoming central council in replacement of Engr. Prof. Dr. Suhail Aftab Qureshi being declared not eligible to conduct the Elections by the house. He also invited the attention of the house to initiate proceedings in the forthcoming CC meeting against Engr. Prof. Dr. Suhail Aftab Qureshi under clause 9 (ii) of the

Constitution in line with observations conveyed by Mr. Riaz Ahmed Tahir Additional Secretary (Estt.) vide no. GS (univ.)11-6/2011-536 dt 16.11.2011 because Misc Writ Petition no. 28040-16 and writ petition 3366-17 are pending since 2016 whereas more than three writ petition have been dismissed.

Engr. Tahir Basharat Cheema suggested that task of suitable replacement be given to the Nomination Committee. He also proposed the names of Engr. Dr. Khawaja Riffat Hassan and Engr. Suleman Najib Khan to be considered for nomination as HSG by the central council. Engr. Suleman Najib Khan refused to contest and requested that their nomination for the office of HSG be withdrawn, whereas Engr. Shahid Aslam conveyed his willingness for the nomination of HSG for the forthcoming central council 2017-19.

The house collectively agreed to nominate Engr. Shahid Aslam for the office of Hony. Secretary General in replacement of Engr. Prof Dr. Suhail Aftab Qureshi and Engr. M. Anwar Qaseem Qureshi as Vice President for the upcoming central council 2017-19.

The meeting ended with the vote of thanks to the chair.

1. Confirmation of minutes of 385th Central Council Meeting.

The minutes of 385th Central Council meeting were unanimously approved by the Central Council.

2. Deliberation regarding approval of membership cases already recommended by Membership Committee in its 205th meeting

The house unanimously approved the 205th minutes of membership committee meeting issued vide #IEEEEP-134/HQ/17/1968 dated 16.08.2017. Below mentioned names of applicants were approved as “Member” & “Associate Member” class amongst the fresh cases as prepared by the office

Engr. Tahir Saleem, Chairman Membership Committee desired that documents pertaining to research papers/Publications and detailed documents of CPD courses conducted by the learned applicant “Engr. Shahid Haider” to be elevated from “Member” class to “Fellow” class may be sort for IEEEEP office record. Hence case is pending for further process and resubmitted upon the receipt of requisite documents from the applicant. Central Council also unanimously approved that at least one membership committee meeting must be held joining office physically face to face after each five meetings held in circulation. However, Central Council expressed complete satisfaction on the speedy processing of the membership cases upto the entire satisfaction of applicants.

3. Deliberations regarding list of persons of the “Proposed Council/Office bearers” for the next Central Council 2017-19 in accordance with IEEEEPBYE-LAWS section 11 sub section (v) read with IEEEEP rules section (I) and (II) concluded unanimously by the Nomination Committee in its 6th meeting held on Friday, 25th August 2017

The list of proposed council /office bearers for the next central council 2017-19 was presented before the central council by the Central Council delegated members committee termed as “Nomination Committee” through its Convener Engr. Mohsin M Syed comprising of Engr. Tahir Basharat Cheema, Engr. S.T.H Naqvi & Engr. M. Anwar Khalid.

The house unanimously approved the recommended list of proposed council /office bearers for the next central council 2017-19 as presented by the membership committee with the following deliberations. Engr. Fazal Rahman reminded the house that the management of 2011-14 were of the view that in future a person from Karachi should be given a chance to lead IEEEEP. Engr. Mohsin M Syed explained that during 2010-14 he remained stationed at Karachi running his one of Business Company HQ camped at Karachi and having good command on Urdu accent. He has been selected as leader of IEEEEP management during 2014-17 being a representative healing from Karachi. However IEEEEP will also keep on considering capable leadership from Karachi in due course of time. Engr. Ijaz Dar pointed out that the person nominated for the seat of Hony. Secretary General IEEEEP 2017-19 has been awarded punishments under the relevant E&D rules by the university (employer) which has still not been expunged, therefore some other clean candidate should have been recommended for the seat. Engr. Suleman Najeeb Khan applauded the services rendered by Engr. Prof. Dr. Suhail Aftab Qureshi for the cause of IEEEEP and stressed that disciplinary awards have no match with the punishments awarded under PPC as those just correspond to differentiate between the efficiency of different co-workers and to push the employee for more hard work and better input. Engr. Shahid Aslam was afraid about nomination of Engr. Prof. Dr. Suhail Aftab Qureshi as Hony. Secretary General with a view that any member of IEEEEP may not raise objection before the Election commission confusing the period of two years with two terms of management mandatory for a candidate to be re-elected against a management seat he has already worked for two years earlier.

The sitting central council has unanimously approved the following list of proposed council /office bearers for the next central council 2017-19. The President is obliged to notify the same to The Election Commission for further process by the Election Commission in pursuance of clause 11 of the Bye-Laws read with article 4 of the “Rules for the Election of the Central Council”.



