## 1. Confirmation of Minutes of 200th Meeting of the Committee

Secretary, A&FC briefed the Committee about the on the minutes of the last meeting and the progress thereof. The members participated in the discussion and unanimously confirmed the minutes of the 200th meeting.

#### 2. Review of Financial Status

Secretary, AF&C presented the updated Bank Statement of IEEEP Current Bank Account along with income & Expenditure Statement and apprised the Committee that as on 18th September 2012, an amount of PKR 1,472,751.84/-was available in the account.

#### Discussion on the Upcoming 34th AGM/Convention to be held at Karachi

Different arrangements pertaining to the event were reviewed by the Committee including acceptance received from the members of Central Council for joining the event, in-time hotel reservation, travelling to and from Karachi, holding of technical seminar, expected quorum/attendance, etc. Engr. Naveed Ansari highlighted that it would not be possible to further delay the event in view of Eid-ul-Adhar and stressed that an early decision is vital in view of the good rates from the hotel. The Committee agreed to refresh the invitation to the members of the Central Council in order to manage greater participation and with the consent of the President, decided to finalize the matter before the next meeting of the Central Council scheduled to be heldearly next month.

#### 4. Adoption of 20% Adhoc Allowance as notified by GoP

The Committee deliberated, on the matter at length and reviewed various aspects including IEEEP income

resources, current financial situation, prevailing inflation rate, etc. and ultimately decided to adopt an increase of 20% in the basic salary with effect from 1st July 2012 as notified by GoP. The Committee hoped that this increase would encourage the employees to work with higher spirit and commitment for achieving the iEEEP's objectives.

#### 5. Any other point with permission of the chair

#### IEEEP HR Manual

Engr. Sails Usman informed the Committee that all changes proposed by the members have been implemented and hard copy of the updated draft manual is being provided to the members. Last part of the manual i.e. job descriptions would be shortly dispatched to the members for their review and comments.

#### · Dissemination of Technical Knowledge

The Committee pondered over the important issue of enhancing the IEEEP income in order to enhance the technical activities by IEEEP. The Committee decided to initiate the CPD training activities, at the earliest, in line with the PEC guidelines. The Committee mandated the already established CPD Committee to develop and implement IEEEP policy (mechanism, roles and responsibilities, etc.) for undertaking CPD training activities by the HQs as well as local centers.

## Request of employees for move over/promotion in service

Following the i) recommendation of AF&C in its 197th meeting, ii) decision by the Central Council, in its 362nd meeting, to delay the matter until HR Manual is finalized and iii) consensus by the Executive Committee in its 1st September Meeting to approve the AF&C proposal, the Committee decided the following incentive/promotions with effect from 1st January 2012:

- a. Mr. Abdu! Ghafoor, Superintendent (Retired in May 2012)
  In view of his dedicated services over such a long period, the Committee decided to financially compensate him with Rs. 4, OOO/- per month with effect from 1st January 2012 to his retirement.
- Mr. Khadim Hussain, Junior Assistant Promotion from B. P. S. 7 to 11
- Mr. Manzoor All, Junior Clerk Promotion from B.P.S. 5 to 9

The Committee reiterated to formalize and implement the IEEEP HR Manual, at the earliest, in order to ensure employees timely promotion on the basis of their performance.

## Minutes of 364<sup>th</sup> meeting of the Central Council of IEEEP

The 364<sup>th</sup> meeting of the Central Council of IEEEP was held on 1<sup>st</sup> October 2012 at 3.00 p.m. in IEEEP office 4-Lawrence Road, Lahore.

The list of participant is attached at annex-1.

The meeting started with the recitation of Holy Quran.

The HSG welcomed all participants and appreciated the record attendance and Council discussed each agenda point as follows,

#### Confirmation of the minutes of 363<sup>rd</sup> meeting of Central Council

The minutes were deliberated at length. There was no observation from any member except Engr. Obaid ur Rahman Khan who clarified para-6 of the minutes regarding approval of new panel of office bearers for IEEEP Karachi Centre and stated that the KLC had no grievances on any allied issue. As such the house deleted the sentence. After this, the minutes were confirmed unanimously.

## Approval of the minutes of 201<sup>st</sup> Admin & Finance (A & F) Committee Meeting.

Engr. Muhammad Azeem, Chairman A & F Committee presented the minutes of the committee for approval of the house. The house discussed key points and approved the same and also decided on the various recommendations as under:

#### Upcoming 34th AGM/Convention to be held at Karachi.

The members discussed the proposed AGM tentatively to be held on 20th October 2012 at Karachi. Different arrangements for the event were reviewed like hotel reservations, mode of travelling to and from Karachi, boarding & lodging and other expenses etc. The members also discussed the proposed subsidized air ticket rates likely to be sponsored by IEEEP. The house keeping in view the different limitations and to ensure greater participation, finalized the date of 10th November 2012 for the AGM. Engr. Obaid- ur-Rahman and Engr. Ahmad Zubair were requested to initiate timely and befitting arrangements for successful holding of the AGM, which they agreed upon.

## Adoption of 20% Adhoc Allowance as notified by GoP & Request of employees for move over / promotion in service.

The house thrashed out the recommendations of A. &F. Committee to adopt 20% Adhoc Allowance w.e.f.1st July

2012 (as notified by GoP) as well as request of employees for move over/promotion in service. The house reviewed the matter and stated that although the IEEEP being an NGO was not bound to follow any notification for governmental employees, still taking a compassionate view decided to consider the case. Engr. M. Anwar Qaseem Qureshi and Engr. Muhammad Afzal pleaded the matter that the Council should be kind enough to provide relief to the IEEEP employees. They urged the house to approve the recommendations of the committee as per its spirit. The house unanimously approved 20% Adhoc Allowance w.e.f. 1st July 2012. The house also approved the recommendations on employee's move-over/promotions w.e.f. 1st January 2012 against each separate case as per following,

- 1. Mr. Khadim Hussain Junior Assistant BS-7 to BS-11
- 2. Mr. Manzoor Ali Junior Clerk BS-5 to BS-9
- Mr. Abdul Ghafoor Sr. Supdt. (Retd.) to be given a special allowance of Rs. 4000/- p.m. for the period January 2012 till his retirement.

#### IEEEP HR Manual

On attention from HSG, the house appreciated the efforts of Engr. Salis Usman, who had adequately done major work on HR Manual. The house decided that there was no need to refer the manual to an HR expert in view of the small size of the staff, hard work done by the Admin and Finance Committee over a long period of around ten months and no precedence in the past to seek HR expert's opinion for such matters. President, IEEEP promised to review and approve the finalized draft in the Executive Committee's forthcoming meeting within a period of two weeks; he also announced to circulate the finalized version among the Central Council members for their reference. Upon the suggestion of Engr. S. S. A. Jafri, the House decided to review the IEEEP HR Manual after six months of its implementation aiming to identify and implement further improvement.

## Approval of the minutes of 189<sup>th</sup> Membership Committee Meeting.

The minutes were read out by the VP (South) as chairman of the membership committee. The house carefully examined all recommendations of membership cases and approved as below,

#### Fellows

 The house agreed not to approve Engr. Irfan Ahmad directly as Fellow and as per traditions consented to support his nomination and election as member initially, thereafter he would be promoted to the Fellowship. He will be informed accordingly. During discussion, the house unanimously decided that the tradition of not allowing direct fellowship to any one be made a part of the rules. This matter was thus forwarded to the Rules Committee headed by the President himself for further necessary action.

The Central Council unanimously endorsed the concluding recommendations, while inducting new members as well as their elevation to next class. However, it required the office to inform and welcome all new members in writing.

#### To finalize the date & to discuss the progress for holding 34<sup>th</sup> AGM/Convention to be held at Karachi. Discussed under para-2(i)

#### 4. Purchase of land for IEEEP HQ building in Lahore.

The President drew the attention of the house toward the remarkable success of the Founder Members of IEEEP, who developed the Institution right from its inception in 1969 to its present eminence. He particularly eulogized the efforts of the founders, who secured the plot for the existing IEEEP building in Faisal Town, Lahore and due to which the Institution was operating in its present shape. He sought appreciation of the house for the landmark achievement. He pledged that the ongoing Council would strictly follow the way of the predecessors and add its own contribution by further expanding its buildings for fulfilling the future requirements particularly in the backdrop of conducting high profile and quality seminars compatible with international standards.

The President apprised that the Pakistan Engineering Council (PEC) had allowed the IEEEP to conduct CPD and EPE programmes. He added that the IEEEP was therefore growing day by day as per its statuary objective to disseminate knowledge in the field of electrical & electronics engineering and related disciplines. The President further stressed the need to capitalize the idea of extending assets. The house endorsed the viewpoint of the President and allowed him to proceed further in the matter.

The President informed the Council that it would be in the fitness of things if all out efforts were made in order to procure properly located plots in Lahore and Karachi to set-up the IEEEP HQ and the IEEEP KLC buildings. He further informed the house that the Central

Council had already decided to assist the KLC through an out-lay of Rs. 5 million for purchase of plot as and when a suitable land was available, while there was the need to immediately buy a plot at Lahore (at an important and up-coming area) for the IEEEP HQ building. It was said that once the plot was available donations and financial help could be garnered for the construction purposes - all which was accepted by the Council. It was then identified that commercial plots of 12 marla (2640sq.ft.) & one Kanal (5280 sq.ft.) in Johan Town adjacent to Expo Centre Lahore had been visited by Engr. Muhammad Azeem, who also visited other nearby places. He highlighted that locations near the Expo Centre were ideal to cater for future requirement and thus requested the Council to deliberate and allow purchase of a suitable plot in the area for the IEEEP HQ Building.

The house permitted the above said acquisition. The chairman KLC, Secretary KLC and the VP (South) also endorsed the decision while qualifying the purchase at Lahore may will not effect the HQ's out-lays for the building at Karachi. Upon proposal of the President, the house constituted committee comprising Engr. Muhammad Azeem as chairman, and Engr. Riaz Ahsan Baig, Engr. M. Irfan Gohar and Engr. Mian Sultan Mahmood as its members to initiate purchase of land around the Convention Centre at Lahore. The house also allowed for payment through a bank loan by securitizing IEEEP existing Building and the saving account of the IEEEP after ensuring the funds to keep on running the office expenses for annual basis as well as for meeting any emergency requirement.

#### Request to USAID/Asia Foundation/HEC for access to e-journals/latest books.

The President informed the house that in order to strengthen the IEEEP library, he had requested with Asia Foundation for grant of valuable books. He apprised that the Asia Foundation had agreed to grant 170 e-books and 700 low priced books for the IEEEP library. The President also reported that letter was being written to the Higher Education Commission (HEC) with request to give access to e-journals of renowned universities and various Institutions. The President then intimated that he had talked to the USAID and requested for the provision of Audio Visual Aids for effective demonstration of CPD and EPE programmes. The USAID had agreed for the grant subject to submission of a cogent request by the IEEEP.

#### 6. Any other item with permission of the chair.

#### IEEEP Sindh Chapter at Sukkar

The HSG, Dr. Suhail Aftab Qureshi drew the attention of the house that most recently, upon his visit to IBA Sukkar, the idea to establish IEEEP Students Chapter at Sukkar was felt intensively. He further said that during the visit, Engr. Obaid ur Rahman Khan Chairman KLC had been requested for more contacts with engineers in the field. If needed, a visit could be made by the HSG, Chairman KLC and Vice President (South) to IBA Sukkar to set up the student's chapter. The house approved the proposal. The President further informed the house that the Pro VC MUET Dr. Uqaili had been requested to set-up the Sindh Chapter of the KLC, who had very kindly consented to do so. The house requested VP(S) Engr. S.S.A. Jafri to contact Dr Uqaili for the new Center at Jamshoro. It was further decided the President and the HSG may visit Jamshoro during their next visit to Karachi to speed-track setting-up of the IEEEP Sind Chapter.

## Resignations of Chairman and Editor IEEEP Board of Publications.

The HSG informed the house that due to busy official engagements, both Dr. Zubair A. Khan and Dr. Asghar Saqib had resigned respectively as the Chairman and Editor IEEEP Board of Publications, which were requested to be accepted by the Council. He further nominated Prof. Dr. Noor A. Sheikh as Chairman IEEEP BOP, Dr. Murtaza Hashmi Associate Professor Electrical Engineering department UET, Lahore, as the Editor. The house unanimously approved the nominations as both the gentlemen had also accepted the positions and required IEEEP HQ for issuance of the notifications. It was further decided acceptance of the resignations of the earlier incumbents in the BOP and special thanks due to them for the services rendered during their incumbency will be communicated to them in written by the HSG.

Under clause 13(a) of the By-laws, the council reviewed the matter of some members, who continuously did not attend the meeting due to their own engagements and considered the nominations for their replacement. The following persons were nominated,

#### Confirmation of minutes of 201<sup>st</sup> meeting of the committee

The Committee reviewed the minutes of the last meeting & the progress thereof and unanimously confirmed the minutes of the 201<sup>st</sup> meeting.

#### 2. Review of Financial Status

Engr. Salis Usman apprised the Committee of the status of IEEEP funds which is as follows:

- Current Account (UBL): Rs. 542,237 As of 14<sup>th</sup> November 2012
- Term Deposit (Faysal Bank): Rs. 9,932,132 (to be matured by June 2013)
- Total Available Funds: Rs. 10,474,369
- Advance rent of IEEEP House expected from NESPAK within this month: Rs. 6,500,000
- Average monthly expenditure (based on the last four months data): Rs. 350,000

#### 3. Consideration of Sub-committee Recommendation for purchase of plot for IEEEP HQ Office

The Committee congratulated the three members Sub-Committee, headed by Vice President, IEEEP constituted by the Central Council and thanked for the committee members' focused concern in the long term interest of the IEEEP. It was observed that the proposed plot i.e. 9-J3, Johar Town, Lahore, measuring I Kanal and 100 sq ft, is located at a walking distance to the Lahore Expo Centre—an ideal location for the future IEEEP HQ office. Total cost of the plot is Rs. 15,500,000; 50% of the amount (Rs. 7,750,000) is to be paid immediately and the remaining 50% within two months i.e. by 10<sup>th</sup> January 2013. The Committee decided to strongly recommend to the Central Council for the purchase of the plot as proposed by the Sub-Committee with the following details:

- Payment of 50% advance from the existing IEEEP funds (Current Account + Term Deposit)
- Payment of remaining 50% by obtaining loan from bank
- Launching of a donation campaign for collecting funds for undertaking the construction of office building in pursuant to the discussions held during the last meeting of the Central Council

#### 4. Any other point

#### · IEEEP HR Manual

Engr. Salis Usman apprised that the staff has presented certain concerns with reference to the development and implementation of the IEEEP HR Manual. The Committee considered each and every concern through detailed discussion and decided the following:

 a. Proposed salary structure is not aligned with the government pay scales

The Committee noted that IEEEP is neither a public sector entity nor a commercial venture as it is a donation based organization. However, the Committee reiterated to consider and take care of the financial issues of the staff with serious concern in case of any change in the government pay scales.

No relief allowance in view of increase in inflation rate

So far A&FC has not defined the new scales/grades in terms of salary; hence it is too early to comment in this respect.

c. Provision of earned leave has been omitted

The Committee decided to restore the earned leave facility for the IEEEP staff.

d. Fixed/flat rate annual increment is denied

The Committee noted that performance based increment/incentive and promotion is the best way to achieve higher individual as well as organizational throughput. Further, it offers greater amount for acknowledging a person's better performance during the year.

The Committee also decided to implement the IEEEP HR Manual as of December 1, 2012 after incorporating the change with respect to the provision of earned leave as demanded by the staff and approved by the Committee.

#### · IEEEP Membership Database

Engr. Salis Usman intimated the finalization of development of IEEEP Membership Database; the new system has been developed in the Microsoft Access format that allows a number of industry standard features including flexible reporting, data portability and sharing. He also informed that the updating of data in respect of all categories would now be undertaken. The Committee decided to release an amount of Rs. 35,000 to the Vital Management Services as the development and implementation cost.

iv. Mr. Riaz Ahsan Baig was requested to prepare the feasibility study of the plot project and then provide copies to the members attending the Central Council meeting.
